If proof of insurance was not shown to the officer, a copy **MUST** be enclosed when payment is made.

All Traffic Minor Misdemeanors not listed in this brochure, \$125.00.

If you are cited for more than 1 offense and have questions regarding payment, please call this office.

ALL FINES MUST BE PAID BY COURT DATE.

Seat Belt Violations

No Seat Belt- Driver	\$ 95.00
No Seat Belt- Passenger	\$ 85.00

Speeding Violations

0 - 10 miles over limit	\$ 100.00
11- 20 miles over limit	\$ 125.00
21 + over limit	\$ 165.00

All 4th offense speed within a 12- month period and Speed 87 MPH and above **MUST** appear in Court.

\$95.00 Waivers

Traffic Control Devices (i.e. Red Light, Stop Sign etc.)
Expired Registration/Under 60 days
Expired Registration/Over 60 days-**MUST** appear in court

\$105.00 Waivers

Expired Operator License/Under 60 days
Expired Operator License/Over 60 days -**MUST** appear in court

Accident Violations

1 vehicle involved (insured)	\$140.00
2 vehicles involved (both insured)	\$165.00

If you were not insured at the time of the accident, you **MUST** appear in court.

Seat Belt Driver	<u>\$95.00</u>

OUT OF STATE DRIVERS: the Court will issue a Non-Resident Violator Compact. Under compact agreement, your state will suspend your driver's license until you satisfy this court.
